PHT B.A. Humus-D.C. may be applied by ground or air methods. PHT B.A. Humus-D.C. is compatible with most dry pesticides and dry fertilizers. PHT B.A. Humus-D.C. is effective when applied to all agricultural crops and all soil types. This product is intended to supplement a regular fertilizer program and may not, by itself, provide all the nutrients normally required.

PHT B.A. Humus-D.C. is a coated leonardite mix manufactured with a proprietary process that allows it to be mixed with Urea and other hygroscopic Nitrogen fertilizers.

**SOIL APPLIED WITH OTHER NUTRIENTS ON AGRICULTURAL CROPS:** Broadcast application is recommended. Mix with all dry fertilizers at a rate of 40 lbs./acre PHT B.A. Humus-D.C. may be applied anytime during the year. For best results make the first application in the fall after deep tillage to let rains carry it in or sixty days before deep tillage is done to allow time for release of Humic Acids. A second application is recommended at pre-plant up to first blossom. Rainfall or irrigation after application can be beneficial.

Can be applied alone at 40 pounds / acre.
