PERSIST ULTRA's unique formulation has been proven to minimize precipitate formation and nozzle plugging in tank mixes with extreme pH ranges that are normally associated with micro rate herbicide applications in sugar beets.

USE RATES

PER ACRE: 1-1/2 to 2* pints

*Use the higher rate when weeds are under weather stress or at the maximum labeled size for control.

BY VOLUME: 1.0% v/v (1 gallon of PERSIST ULTRA per 100 gallons of spray solution)

MIXING

Always mix this product in accordance with the instructions found on the pesticide label concerning adjuvants. In the absence of specific mixing instructions, fill the spray tank 1/2 to 3/4 full of desired water volume. While the water is agitating, add tank mix ingredients in the following order: Add compatibility agents, solubilizers or pH modifiers; if foaming is anticipated, use an antifoam/defoamer; ammonium sulfate, fertilizers or micronutrients; pre-slurried pesticides; water-soluble packets, dry flowables and dispersible granules; flowables; emulsifiable concentrates; PERSIST ULTRA; Finish filling sprayer with desired water volume.

STORAGE AND DISPOSAL

Storage: Store above 32°F. Protect from freezing. If product freezes, warm to room temperature before reuse. Store in original container only and do not reuse empty container.

Disposal: Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
