GENERAL DESCRIPTION:

GREEN M.I.L.E. is specially formulated to provide delivery of critical and important nutrients throughout the season. The sources of nutrients in alfalfa, fish, crab, and poultry waste meal as well as in kelp also promote microbially active soils. Further, soil microbiologists have found the biology of the soil to be of equal to greater importance than mineral constitution alone. The soft fertility characteristics minimize opportunity for phytotoxicity and facilitates use on a variety of crops spanning herbaceous annuals to woody perennials. The product is formulated for mechanical application.

CAUTION: The slight hygroscopic properties necessitates storing in a cool, dry location. Also, once placed in an applicator, attempt to dispense this material within 6-8 hours. Consult a technical representative for specific procedures and uses.

DIRECTION OF USE:

Stone Fruit & Nut Crops:

Depending on analyzed needs, apply between 250-1,000 lbs per acre. Broadcast evenly around the root zone and incorporate mechanically or via irrigation. Increment applications as opposed to applying one treatment.

Vine Crops:

Based on soil mineral characterizations, apply between 200-600 lbs per acre. Wherever possible, increment applications.

Vegetable & Field Crops:

Following analyzed mineral requirements, apply between 250-800 lbs per acre. List into beds as well as side dressing.

Ornamentals:

Integrate and select applications as outlined above. Generally, this rate will run between 5-10 lbs per 1,000 sq. ft.
