### STATEMENT OF PRACTICAL TREATMENT

- If Swallowed:** Do not induce vomiting unless directed to do so by medical personnel. If individual is fully conscious, give a large amount of water to drink. Never give fluids or force vomiting if the individual is unconscious, is having convulsions or has no gag reflex. If large quantities are swallowed, seek immediate medical attention.
- If Inhaled:** Move individual to fresh air. If breathing is difficult, give oxygen, or if not breathing, give artificial respiration, and seek immediate medical attention.
- If In Eyes:** Check for and remove contact lenses. Immediately flush eyes with water for at least 15 minutes. Cold water may be used. Seek medical attention if irritation occurs.
- If On Skin:** Wash affected area with plenty of soap and water. Cold water may be used. Seek medical attention if irritation develops.

**GENERAL INFORMATION**—FS Transform Plus is a convenient, low-use-rate, activator adjuvant premix that combines water conditioning agents, drift retardants and ammonium ions in an easy-to-use formulation. FS Transform Plus sequesters antagonistic hard water ions, provides additional ammonium ions for improved herbicide uptake and reduces drift risk to ensure optimum performance of glyphosate-based herbicides.

FOR USE WITH PESTICIDES REGISTERED FOR AGRICULTURAL, FORESTRY, INDUSTRIAL, MUNICIPAL, NON-CROPLAND, RIGHTS-OF-WAY AND OTHER APPROPRIATE USES.

**DIRECTIONS FOR USE**—Always mix and apply this product in accordance with the instructions found on the pesticide label regarding adjuvants. In the absence of specific instructions follow the application and mixing guidelines below.

**APPLICATION RATES**—Using the guidelines below, mix FS Transform Plus at 1–4 quarts per 100 gallons of spray solution (0.25–1.0% v/v).

#### NOTE: Use the higher use rates when any of the following conditions exist:

- Nitrogen responsive weed species, such as velvetleaf, are present or weeds are under weather stress conditions.
- Additional drift control is desired due to weather conditions, nozzle selection or application technique.

#### Use the lower use rates when:

- Visual inspection indicates excessive reduction in the appropriate overlap of the spray pattern.

**MIXING INSTRUCTIONS**—In the absence of specific mixing instructions found on the pesticide label, fill the spray tank 1/2 to 3/4 full of desired water volume. While the water is agitating, add tank mix ingredients in the following order:

1. FS Transform Plus.
2. Additional ammonium sulfate, if required by herbicide label.
3. Water-soluble packets, dry flowables and dispersible granule pesticides.
4. Flowable pesticides.
5. Water-soluble pesticides.
6. Emulsifiable concentrate pesticides.
7. Finish filling spray tank to desired level and continue agitation.

**STORAGE AND DISPOSAL**—Do not use, spill or store near heat or open flame. Keep container closed tightly when not in use. Prevent water from being introduced to the contents of this container. Protect product from freezing. Do not reuse empty container. Rinse container thoroughly, disposing of rinsate and the container in accordance with federal, state and local regulations.
