To control fungal diseases in turf grasses, including dollar spot (Sclerotinia), fusarium blight (Fusarium), leaf spot (Helminthosporium), brown patch (Rhizoctonia), fadingout (Curvularia), pythium, fairy ring, rust, toad stools, and algae on turf, spray a solution of one pint (16 fluid oz) of CONSAN TURF in sufficient water to treat10,000 sq ft or 1/4 acre. Treat entire area to prevent spread of infection or at least one foot beyond the edges of isolated diseased areas. Saturate the entire treatment area, wetting all turf surfaces thoroughly. Repeat spray applications every 10 -14 days, as needed to control new or established disease conditions. Treatment is required during the warm growing season and may be made when the turf is dry or damp, but not during wet rainy weather.
