GENERAL INFORMATION:

SOYSURF X-TRA is a unique oil based surfactant, nonionic surfactant, and trisiloxane in liquid nitrogen. It is designed for use in pesticide sprays to increase activity, aid in penetration, and provide uniform coverage. The oil based surfactant works as a replacement for crop oil and MSO in the present of silicone in a liquid nitrogen solution.

DIRECTIONS FOR USE:

PREPARATION AND APPLICATION OF SPRAY EMULSIONS: Fill spray tank half full with water, add the proper amount of herbicide while agitating and then add SOYSURF X-TRA. Continue to agitate while finishing filling and agitate before and during each application to insure a uniform spray emulsion.

By ground: 4 quarts per 100 gallons of water or 1% by volume

By air: 3.2 – 6.4 oz per acre in 1-5 gallons of water

12.8 oz per acre in 10 gallons of water or 1% by volume

NOTE: SOYSURF X-TRA increases the activity of herbicides and therefore care should be exercised when herbicide sprays containing SOYSURF X-TRA are applied to new crop varieties or highly inbred crop lines not previously treated with SOYSURF X-TRA. Care is recommended when sprays are applied under very humid conditions or under circumstances when herbicides tend to be more active. In new uses it is recommended that small test areas be treated before undertaking large scale applications.
