#### **FIRST AID**

# **GENERAL INFORMATION**

**SAP vg** is an anti-transpirant agent intended for use with fruits, vegetables and other uses to reduce moisture loss by the plants. Adding a thin coat of **SAP vg** can provide a water impermeable film that reduces water loss from transpiration. Use on fruits and vegetables to improve size, reduce pre-harvest fruit drop, minimize sunburn incidence, and improve color in some varieties.

Application of **SAP vg** can improve the establishment and survival of plants exposed to stressful or adverse environmental conditions. Spray **SAP vg** for full coverage or use as a dip.

**SAP vg** needs to be applied at least one hour during daylight, before an anticipated rainfall. Sunlight is needed for this period of time, for the protective film to set. No additional spreader is needed with **SAP vg**.

# **DIRECTIONS FOR USE**

Fill the spray tank with 1/2 - 3/4 of the required amount of water and begin agitation. Add the recommended amount of **SAP vg** and add the balance of water. Maintain agitation during mixing and spraying to ensure a uniform emulsion. It is also advisable to pre-mix **SAP vg** with water, before adding to the spray tank.

The applicator/user must have experience with this product or must conduct a phytotoxicity test at the full use rate on a small test patch or on a plant BEFORE starting large scale usage.

# **USE RATES**

**Fruits:** Apply **SAP vg** at the rate of 1 gallon per acre in enough water for good coverage (100 to 500 gallons per acre). Do not use in a spray tank combination with any pesticide. Make application about 4-6 weeks before harvest.

**Vegetables: SAP vg** is applied at 1 gallon per acre in adequate water (approx. 100 gallons per acre) for good coverage.

**Turf:** 1 gallon per 40 or 50 gallons of water. Apply thoroughly until leaves are completely covered.

# STORAGE AND DISPOSAL

Store in a cool, dry place. Product may become thick in cold temperatures. If product is too thick to pour, let stand in warm area until thin enough to pour. DO NOT expose to fire, flame or extreme heat. Keep in original container tightly closed. Do not reuse empty container. Triple rinse storage container when empty and dispose of rinsate properly. Then offer container for recycling or reconditioning, or puncture and dispose of in a sanitary landfill. If incineration is allowed, stay out of smoke. Dispose of in accordance with local, state or federal regulations.
