GENERAL DESCRIPTION:

A micronutrient mineral supplement for foliar and/or drip applications to trees & vines, vegetable & field crops, turf & greenhouse plants, and various ornamental species.

Z - 422 may also be used to provide extra protection ahead of and during periods of physiological or environmentally induced stress periods.

Z - 422 may be used with most fungicides, insecticides, adjuvants or nutrients.

CAUTION: Keep out of direct sunlight and temperatures over 105 deg F. Fill the spray tank at least ¾ full with water before commencing with blending of various spray materials.

DIRECTIONS FOR USE:

Stone Fruit, Nuts, Citrus & Olives:

Applied near bloom and continued periodically throughout the growing season.

Foliar: 1pt21qt/100 gals near bloom and during the growing season.

Soil: Irrigated—1qt-2g/ac
Blended w/ Fertilizers -2qt-2 gal/ac

Vine Crops: Apply ahead of bloom and periodically throughout the season.

Foliar: ½-1 pt/100 gals

Soil: Irrigated—2qt-2 gal/ac
Blended w/ Fertilizer—2qt-2 gal/ac

(Note: Apply at lower rates for initial 2 sprays increasing rates thereafter)

Vegetable and Field Crops & Berries: Apply starting at 3rd-4th leaf stages and periodically throughout the growing season.

Note: For Berries consult a technical representative for late season/maturity rates

Foliar: ½-1 pt/100 gals

Soil: 1qt-1 gal/ac

Ornamentals: Apply periodically throughout the growing season.

Foliar: 1pt/100 gals

Soil: ¼-2 oz per 1,000 sq ft

Alfalfa: Apply 2 weeks after cutting and/or harvesting. Always include with a spray of FG-31 1-0-2 and Integrity 9.5% Calcium @ 3-4qts/100 gals

Foliar: 1 pt.—2 qts/100 gals

Soil: 1pt—1 gal/ac

Tropical Fruits: Apply from 3rd-4th leaf stages throughout the growing season.

Foliar: ½-1 pt/ 100 gals

Soil: 1 pt-1 qt/ac
