

# PASSPORT™ 8-24-6

For Foliar or Soil Application



## 8-24-6

### General Information

PASSPORT™ is a “state of the art” complete plant food containing multiple phosphate sources, an enhanced micronutrient package from EDTA. PASSPORT as a starter in or sprayed over the top of the row to promote root development and early seedling growth, by supplying nutrients vitally needed by young plants under cool, wet spring conditions. Continue with multiple applications throughout the growing season to provide a continuous supply of nutrients at or near the time they are needed most.

### Directions for Use

PASSPORT can be used with most pesticides. Always make a jar test. Mixing Instructions: Use only the following sequence:

1. Water
2. This Product
3. Pesticides or fertilizers

Rates and timing of applications are dependent on local conditions and should always be made as a result of soil and/or plant tissue analysis. Local climatic conditions, infestations and other factors affect the performance of any pesticide or nutritional spray. Therefore, consult your local chemical company representative or agricultural extension agent for specific use information in your area.

### Recommended Rates

**SOIL APPLICATION:** Apply 2-4 qts./acre at planting as a row starter or in covering soil.

#### FOLIAR APPLICATION:

**Cotton:** Apply 1-2 qts./acre in a band over the row in enough water to give good coverage. Use 2-4 qts./acre in a broadcast spray.

**Peanuts:** Use 2-4 qts./acre early season. Repeat before bloom and continue at 10-14 day intervals.

**Soybeans:** Use 2-4 qts./acre with each application starting no later than first bloom. Continue as needed through pod development.

**Vegetables:** Use 1-4 qts./acre depending on size of plants. First application should be made prior to flowering and/or fruiting. Continue throughout season at 7-10 day intervals.

**Alfalfa Hay:** 2-4 qts/ac broadcast.

**Other Crops:** Use 1-4 qts./acre starting no later than first bloom or fruiting stage and continue every 10-14 days along with regular spray program.

**Tobacco & Other Transplants:** Apply at the rate of 2-4 qts./acre in transplant water or banded over the row.

**STORAGE and DISPOSAL:** Store product in the original package. Store in cool, dry facility away from oxidizing agent. Dispose of this container in an environmentally safe manner as recommended for your area. Do not contaminate water, food, or feed by storage or disposal.
