PRODUCT INFORMATION:

NUTRIMIN IRON contains chelated mineral for soil and foliar applications. It is readily available and non-phytotoxic to plants when applied in accordance to directions. It is designed to prevent and correct mineral deficiency. It may be applied with nitrogen fertilizer.

DIRECTIONS:

SHAKE WELL BEFORE USING SOIL APPLICATION:

NUTRIMIN IRON can be applied before or at planting as banding or broadcast. The application rate is 1 quart to 1 gallon per acre depending on soil conditions and application methods. For maintenance 32 oz. per acre is recommended.

FOLIAR APPLICATION:

FIELD CROPS: Apply 16-48 oz. of **NUTRIMIN IRON** per acre when crops are about 6-12 inches high or when deficiency symptoms appear. Repeat application in 2-4 weeks if necessary.

FRUIT TREES AND GRAPES: Apply 16-48 oz. of **NUTRIMIN IRON** per acre in early spring when new leaves are emerged or when deficiency symptoms

VEGETABLE CROPS: Apply 16-48 oz. of **NUTRIMIN IRON** per acre at about 2-4 weeks after emergence, or when deficiency symptoms appear. Repeat the application in 1-3 weeks if necessary.

For best results, apply **NUTRIMIN IRON** when the crop is in active growing stage, after irrigation or natural rain fall. For foliar application, it should be diluted with at least 100 times of water.
