**HERBICIDES** - Use “80-20” SURFACTANT at the rate of 1 quart per 100 gallons of spray mixture to obtain 1/4% surfactant. Use 2 quarts per 100 gallons of spray mixture to obtain 1/2% surfactant.

**INSECTICIDES AND ACARICIDES** - Use “80-20” SURFACTANT at the rate of 2 to 8 ounces per 100 gallons of spray mixture.

**DEFOLIANTS AND DESICCANTS** - Use “80-20” SURFACTANT at the rate of 1 to 4 pints per 100 gallons of spray mixture.

**STORAGE AND DISPOSAL**

Do not store near heat or open flame.

Do not reuse empty container. Triple rinse, puncture, and dispose of in a sanitary landfill or by incineration or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.
