GENERAL INFORMATION

CHEM-KEY™ LIQUID ZINC is a complexed liquid micronutrient compound containing sulfur and zinc. It is designed for foliar and soil application for prevention and correction of zinc deficiency. It is recommended for use as an additive in liquid or dry fertilizers. It is compatible with most agricultural pesticides.

CHEM-KEY™ LIQUID ZINC tank-mixed in water will decrease alkaline hydrolysis associated with organo-phosphate pesticides.

CHEM-KEY™ LIQUID ZINC is NOT RECOMMENDED for use with pesticides that are not compatible with acid materials. *DO NOT MIX WITH HIGH PHOSPHATE LIQUID FERTILIZERS.*

DIRECTION FOR USE

CHEM-KEY™ LIQUID ZINC may be applied by ground or aerial application. Use sufficient water for thorough and uniform coverage of foliage or soil. Foliar application is recommended when fast correction is desired. For best results use a non-ionic surfactant.

CHEM-KEY™ LIQUID ZINC will disperse in water with minimal agitation. It serves as a buffer when used in tank mixes with pesticides.

Always check compatibility before mixing. Use only the following sequence:

- 1. Water
- 2. CHEM-KEY™ LIQUID ZINC
- 3. Pesticide or fertilizers.
