## GENERAL INFORMATION

**CHEM-POLY™ 10-0-10 0.5% B** is a liquid foliar nitrogen designed for application on cotton and other crops requiring supplemental N during the growing season. A portion of the nitrogen is in a slow release form providing more efficient nitrogen utilization. In addition, it contains boron often deficient in certain crops suffering from disease pressure or drought conditions.

**CHEM-POLY™ 10-0-10 0.5% B** is recommended as a carrier for pesticides. The slow release nitrogen prolongs the wetting of leaf surfaces for greater penetration and less loss from crystallizing on leaf surfaces as with liquid urea products.

## DIRECTION FOR USE

This product may be applied by ground or aerial application. Use sufficient water for thorough and uniform coverage of foliage or soil. Foliar application is recommended when fast correction is desired. For best results use a non-ionic surfactant.

### Mixing Instructions:

Always check compatibility before mixing.

Use only the following sequence:

1. Water
2. **CHEM-POLY™ 10-0-10 0.5% B**
3. Pesticides
