DIRECTION FOR USE

CNI MANDATE™ LIQUID MANGANESE is to be tank-mixed in a prescribed sequence as follow:

1. Water
2. Ammonium sulfate
3. **CNI MANDATE™ LIQUID MANGANESE**
4. Glyphosate or other herbicide

RECOMMENDED RATES

Apply at the rate of 1-2 qts/acre in 10-20 gallons of water. Manganese does not translocate to new growth. Accordingly, a second application maybe necessary.
