GENERAL INFORMATION

Golden Bio can be applied to all crops including: vegetable, row, field, feed, trees, vines, ornamentals, lawns, gardens, and landscaping. Golden Bio can be mixed with liquid fertilizers and liquid nutrients. Golden Bio can also be applied with non-selective contact herbicides, systemic insecticides, and can be mixed with most fungicides and defoliants. If this product has not been used in the past with the fertilizer or pesticide selected, use the standard jar test to determine compatibility. This product is intended to supplement a regular fertilizer program and may not, by itself, provide all the nutrients normally required.

Golden Bio can be added to all foliar sprays. Soil applied fertilizers and nutrients are best applied with PHT B.A. Humus.

DIRECTIONS FOR USE

FOLIAR APPLIED:

Apply up to 8 quarts per acre, per application. Apply at least 1 quart per acre in all foliar applications. Use higher rates as spray volume increases. Golden Bio can be piggybacked with all foliar feeds. If sprayed without mixing with other nutrients, dilute in at least 10 gallons of water.

HERBICIDE APPLIED:

Apply 1 quart to 2 quarts per acre. Golden Bio can be mixed with non-selective contact herbicides but is not recommended with pre-emergence herbicides. DO NOT MIX WITH SELECTIVE HERBICIDES.

TRANSPLANTING OR CUTTING:

Mix $\frac{1}{2}$ to 1 gallon of Golden Bio per 20 gallons of solution. Golden Bio can be applied with all transplant solutions, dips and all watering solutions.

DEFOLIANT APPLIED:

Mix 1 quart to 2 quarts of Golden Bio per acre with all defoliants.
