**COMPATIBILITY:** Always jar test new combinations for compatibility prior to field mixing.

### Note

Do not store in diluted form. Keep sealed in air and moisture tight container. Place opened sacks in sealed plastic bags preventing moisture contamination and caking.

### Directions

#### Orchards and Vineyards

Spray 1/2-2 lbs. FP-LL15 Fish Hydrolysate mixed in 20-400 gallons of water per acre (1/2-2 lbs. per 100 gals. Spray to cover is suggested). Begin 4-6 spray sequence at pink-bud or half leaf emergence and repeat at 7 to 10 day intervals. May be tank mixed with most orchard and vineyard spray materials.

#### Row Crops

Spray 1/2-3 lbs. FP-LL15 mixed in 20-400 gallons of water per acre (1/2-3 lbs. per 100 gal. spray to cover is suggested) on emerging new growth and at other plant growth stages when an immediate nutritional boost may be beneficial to growth, production and quality.

#### Ground Application

FP-LL15 Fish Hydrolysate may be applied dry or preferably in solution at 2-5 lbs. per 100 gals. as desired. Solution can be shanked in at time of seeding field crops. Ocean Grown Hydrolyzed Fish will not clog emitters and used as a "side dressing" even with systems using micro perforated drip irrigation tape with sheet mulching and row covers.

## Soluble Dry Powder

FP-LL15 is an organic fertilizer and fish protein supplement. It can be used applied directly to the soil or used as a foliar spray application. Use during all stages of growth for improved crop quality, performance, and yields.
