## GENERAL INFORMATION

P-Finisher is a concentrated mixture of potassium fertilizer. It is a high pH fertilizer, which is designed as a late season foliar application to specific varieties of potatoes only.

## DIRECTIONS FOR USE

**Mixing Directions** - Be sure spray tank is thoroughly cleaned, fill 1/2 full with clean water, add product and continue filling with agitation. Always add this product to tank before adding pesticides.

**Compatibility** - P-Finisher is recommended to be applied by itself. It is a high pH fertilizer that is not compatible with most other fertilizers.

**Applications** - P-Finisher can be applied by ground equipment or air. USE at least 15-25 gallons/acre of water carrier.

**Dilution and Spray Volumes** - Always use enough water for uniform application and to prevent possible plant tissue damage to the intended crop from concentrated droplets.

**Containers - Triple Rinse.** Dispose of containers only in a manner approved by local and state authorities.

## SUGGESTED APPLICATIONS

**THIS PRODUCT WILL CAUSE SEVERE CROP DAMAGE WHEN APPLIED INCORRECTLY or TO THE WRONG CROP.** We strongly recommend that this product is used with the advice of a qualified crop nutrient consultant.

## RATES

Apply P-Finisher at 2 to 8 quarts per acre as a predetermined % solution foliar. Final application rate should only be determined by spraying a small plot with a hand sprayer first!

Mix desired %-solution (5-12%), spray plot and wait 1-2 days. Take the rate with the desired amount of foliar effect, decrease by 0.5%. Use this rate for the whole field

The product is usually applied at 5-8% solution (5-8 gallons per hundred gallons). It is recommended to use at least 20 gallons per acre.
