## GENERAL INFORMATION:

Row Root Starter is intended as a ready-to-use starter material or for use as a seed pop up. This material contains .74 lbs of Nitrogen and 2.24 lbs of P<sub>2</sub>O<sub>5</sub> in each gallon. It is intended for use as a soil applied material. This product is intended to be a supplement to a fertility program. Always monitor crop nutrient needs and responses with a soil, leaf tissue and irrigation water analysis program.

## DIRECTIONS FOR USE:

Soil apply via mechanical application through direct spray or injection to the soil. Mix with sufficient water for adequate mixing and coverage of target areas. Material should be applied in contact with, or in close proximity to the seed.

## COMPATIBILITY

This product has a mildly acidic to near neutral pH, and should generally be applied as a stand-alone application. User assumes full responsibility to ensure product, equipment and plant compatibilities.

## SUGGESTED CROPS, RATES & TIMINGS

### FIELD CROPS & ROW CROPS

At planting (i.e. pop up, starter, listing, etc.), apply 2 gallons per acre with sufficient water for thorough coverage. Material should be applied in contact with, or in close proximity to the seed.
