GENERAL INFORMATION

Foundation 21 is a humic acid solution extracted from leonardite. Foundation 21 is formulated with a form of nitrogen derived from fermented grain by-products. Foundation 21 is primarily designed for soil and water run applications in combination with fertilizers.

DIRECTIONS FOR USE:

Foundation 21 can be applied by side dress and banding equipment, water run through irrigation systems or sprayed directly on soils with other fertilizer materials. Foundation 21 can also be impregnated into dry fertilizer blends.

It is recommended to shake, stir or agitate the containers or tanks of Foundation 21 just prior to usage.

STORAGE & DISPOSAL:

Store in original containers at temperatures above freezing. Dispose waste at approved disposal facility. To dispose of containers, triple rinse and dispose according to local and state regulations.

SUGGESTIONS FOR USE:

Foundation 21 can be soil applied and water run on all crops at rates of 1 to 10 gallons per acre.

It is best to use materials in split applications with other fertilizer and micronutrient products at 1 to 3 gallons per acre in 2 to 4 applications.

When applications are sprayed or applied directly to soil without other nutrients, dilute in 3-10 gallons/acre of water prior to application.

Do not contaminate feed or food items.

Use caution in application to assure coverage on intended treatment areas only.

NOTICE:

Since many pesticide products can be neutralized and/or tied up by soil organic matter, it is highly recommended not to use pesticides applied directly with humic acids. Consult pesticide representative before using on a large scale.
