GENERAL RECOMMENDATIONS

FOR USE AS A SOIL APPLIED NUTRITIONAL SPRAY

SOIL APPLICATION: TECH-CARB can be applied alone or with other fertilizer materials in starter, broadcast, water run, injection or side dress applications. When applying with other nutrients it is recommended to dilute TECH-CARB with 2-10 gallons of water with the other fertilizer. When applying in drip systems, add TECH-CARB after any sand filtration equipment.

COMPATIBILITY: This product is compatible with most commonly used insecticides, fungicides and acaricides. However, it is not feasible to test all possible combinations of products with which it may be mixed. A compatibility test is recommended for combinations that have not been used previously. TREE CROPS - Apply 2-4 qts. per acre per application starting pre-bloom. Repeat every 4-6 weeks as necessary.
