FIRST AID

CALL A POISON CONTROL CENTER OR DOCTOR IF YOU FEEL UNWELL

If in Eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses if present, after the first 5 minutes, then continue rinsing the eye. Get medical attention.

If on Skin or Clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

If Swallowed: Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by a poison control center or doctor. Have person sip a glass of water if able to swallow. Do not give anything by mouth to an unconscious person.

If Inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible.

GENERAL INFORMATION

EXURO is a modified vegetable oil concentrate that increases herbicide absorption and penetration into the plant for tough burndown and desiccation applications. It is designed for use with a broad range of herbicides especially burndown applications in the spring or fall, fallow applications, or with crop desiccants. EXURO can be applied by ground or air. Good judgment and sound application technology must always be followed when spraying pesticides.

DIRECTIONS FOR USE

Prior to use read all directions on this label and on the label of the product used. The product label for specific usages and restrictions have precedence over directions for uses referred to on this label.



MIXING INSTRUCTIONS

1. Fill sprayer 1/3 to 1/2 full of water
2. Add dry flowables or dispersible granules
3. Add emulsifiable concentrates
4. Continue to agitate until tank is 3/4 full
5. Add EXURO last to the agitating spray tank

RECOMMENDED RATES

EXURO should be applied at a rate of 1 to 2 pints per acre. Alternatively, EXURO can be applied at a rate of 1 gallon per 100 gallons or 1% v/v. Use the higher end of the rate on hard-to-control weeds or weeds under stress for optimum effectiveness.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry place. Store in original container only. Do not store near feed or food. Store between 40°F and 120°F. Do not contaminate water sources with equipment wash water, spray disposal wastes or by cleaning of equipment. Do not use or store near open flame.

Disposal: Do not reuse product containers. Triple rinse (or equivalent), then offer for recycling at an ACRC site (go to <http://www.acrecycle.org/> for locations) or by reconditioning, or puncture and dispose of in a sanitary landfill or by other procedures approved by local, state, and federal regulations.
