When used in conjunction with sound fertility practices, NUTRI-LINK HP STARTER 8-27-0 improves quality and production for a wide range of agricultural practices.

SPRAY MIX COMPATIBILITY

Applications of **NUTRI-LINK HP STARTER 8-27-0** with pesticides are possible provided that good agitation of the spray mix is maintained. Always check compatibility prior to mixing and apply the spray mix as soon as possible. Follow the mixing sequence below:

- 1 Wate
- 2. NUTRI-LINK HP STARTER 8-27-0
- Pesticides.

NUTRI-LINK HP STARTER 8-27-0 is compatible with most liquid fertilizer/pesticide spray mixes at manufacturers specified label rates. However, it is recommended that a "jar test" be performed prior to actual application. In the event of fertilizer/pesticide compatibility problems, the addition of a stabilizing/compatibility agent is recommended. Follow the mixing sequence below:

- Water
- 2. Fertilizer
- 3. NUTRI-LINK HP STARTER 8-27-0
- 4. Approved compatibility agent (if needed according to jar test)
- Pesticides

SOIL APPLICATIONS ONLY

For starter applications that are applied in-furrow or banded and broadcast through conventional equipment, use NUTRI-LINK HP STARTER 8-27-0 at the rate of 3-5 gallons per acre. Best results are obtained when NUTRI-LINK HP STARTER 8-27-0 is incorporated, injected, or applied alone in a zone or band in the soil or with fertilizer at a minimum depth of two (2) to four (4) inches. Use in accordance with recommendations of a qualified individual or institution, such as, but not limited to, a certified crop advisor, agronomist, university crop extension publication, or apply according to recommendations in your approved nutrient management plan.
