GENERAL INFORMATION

RESERVOIR® SP contains a special mixture of ingredients that perform synergistically to both wet hydrophobic soils and retain moisture in the soil profiles. Use RESERVOIR® SP as a superior irrigation management tool that provides dependable soil wetting over a wider range of conditions than standard soil wetters. The combination of surfactants and humectants puts water in the right area and holds it there better for good plant growth and additional plant vigor.

RESERVOIR® SP is designed to improve moisture retention in areas that do not hold water well. Use RESERVOIR® SP in turf and ornamental areas such as dry, sloped or where moisture permeation and retention is less than optimal. In ornamental sites, take care to keep sorav directed at the ground.

DIRECTIONS FOR USE

RESERVOIR® SP may be applied with hand held or ground applied spray equipment, hose end applicators or may be injected through irrigation systems. Care should be taken by testing this product on sensitive plants before full application is performed. Apply on 30 day intervals or as needed.

RESERVOIR® SP can be used on fairways, roughs, approaches, commercial and residential turf, athletic fields, parks, institutional and other similar turf sites. Use on golf greens and tees should be applied at the highest dilute rate. Additional soil wetters such as One Putt, Injector or Soaker Plus can be applied with RESERVOIR® SP to aid in infiltration and to reduce irrigation puddling.

Premixing: Do not premix this material with fertilizers, pesticides or other materials. Add to directly water in spray tank or inject into irrigation only.

Spray tank mix: Prior to adding RESERVOIR® SP to the tank, insure that the tank is clean from any residue from previous applications. Use a tank cleaner such as Wipe Out and rinse thoroughly. RESERVOIR® SP can be tank mixed with water or other soil wetting agents. Prior to any additional tank mix combinations please consult your Helena Representative. Tank mix combinations with RESERVOIR® SP are at the sole discretion of the applicator and should be jar tested prior to mixing and application. Follow application rates below adding RESERVOIR® SP directly to tank water with agitation running.

Irrigation injection: Using the application rate below, add RESERVOIR® SP into the

irrigation by means of a metering pump.

Nozzle recommendations: Use ASABE coarse, or extra coarse or flood-type nozzles only for ground, pull behind and hand applications. Spray immediately after mixing if used in a tank mix. The use of fine or medium spray nozzles or allowing the mixture to sit for more than 4 hours may cause issues during application.

Post application: Immediately after application, follow product with 1/2 to 1 inch of irrigation over the entire application area. Note: Until this post application irrigation is performed, the area will be slippery. Anti-slip safety precautions must be used.

APPLICATION RATES

Irrigation Injection: Inject 2-3 qts of RESERVOIR® SP per acre through the standard irrigation cycle.

Ground applied Spray Equipment: 2-3 qts per acre in 80-130 gallons of water per acre.

Hand Held Spray Equipment: 1.5-2.5 oz per 1000 sq ft. with enough water to provide adequate coverage of RESERVOIR® SP.

Hose End Applicator: Calibrate hose end applicator to deliver 1.5 oz -2.50 oz of **RESERVOIR® SP** per 1000 sq ft.

Ornamentals: Use 2 qts per 100 gallons of water and apply to soil or potting media until wet.

STORAGE AND DISPOSAL

Storage: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

Disposal: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
