### APPLICATION RATES AND TIMINGS

**Alfalfa:** 10 to 16 fl. oz. per cwt of seed.

**Beans:** 6 to 12 fl. oz. per cwt seed.

**Cereals:** 4 to 9 fl. oz. per cwt of seed.

**Corn:** 6 to 12 fl. oz. per cwt of seed.

**Cotton:** 8 to 24 fl. oz. per cwt of seed.

**Peas:** 6 to 12 fl. oz. per cwt of seed.

**Rice:** 6 to 15 fl. oz. per cwt of seed.

**Soybeans:** 6 to 12 fl. oz. per cwt of seed.

**Sunflower:** 6 to 15 fl. oz. per cwt of seed.

**Finger Planters:** Manufacturers' recommendations for use of graphite should be followed. Failure to do so could result in reduced plantability.

**Vacuum Planters:** Manufacturers' recommendations for use of graphite and/or talc should be used in conjunction with the correct seed disk.
