TURF RECOMMENDATIONS:

Apply 2 - 3 quarts per acre or 1½ - 2¼ oz./1,000 sq. ft.

ORNAMENTAL RECOMMENDATIONS:

Apply 2 - 8 quarts per 100 gallons of water either as a foliar spray or deep root injection.

CAUTION: DO NOT apply to ornamentals that are under drought or moisture stress.

MIXING AND APPLICATION GUIDE:

High Volume Sprayers: Use 350 - 800 gallons of water per acre.

Conventional field turf sprayers: Use minimum of 15 - 20 gallons per acre or enough water for thorough coverage.

Air application: Use minimum of 5 gallons of water per acre.

In mixtures where compatibility agent is necessary, a product such as **BUFFER P.S.** is recommended. Thorough coverage is necessary for best results and the addition of a nonionic surfactant such as **INDUCE®** is recommended.
