GENERAL INFORMATION

PROMATE® SCATTER® is a blend of nonionic wetting agents impregnated onto an inert organic carrier. This results in a dry granular formulation that provides equal performance as liquid products when used at recommended rates. **PROMATE® SCATTER®** can be applied safely at full rates in both spring and summer.

PROMATE® SCATTER® is particularly useful for treating small areas of difficult to wet soil. **PROMATE® SCATTER®** also contains agents to prevent foaming problems.

DIRECTIONS FOR USE

GREENS & TEES

In general, **PROMATE® SCATTER®** 21 lbs./1000 square feet every six month.

Early Season Applications: **PROMATE® SCATTER®** 6 lbs./1000 square feet.

Apply when turf is dry. Rainfall or irrigation providing a minimum of 0.1 inch of water is necessary to activate the product. If necessary amounts of water have not been applied before next mowing, leave the baskets off.

Monthly Applications: If applied on a monthly maintenance basis, **PROMATE® SCATTER®** 3 lbs./1000 square feet.

Spot Treatments or Supplemental Applications: **PROMATE® SCATTER®** 3 lbs./1000

square feet every 7 days or until problem is corrected.

NOTE: Rates given have been effective over a wide range of applications. Some applications may require lower, or higher rates for optimum performance.

Experimentation will reveal the optimum rate for your specific application.

FAIRWAYS, LAWNS, ATHLETIC FIELDS

PROMATE® SCATTER® 9-12 lbs./1000 square feet every 6 months.

Growing Season: **PROMATE® SCATTER®** 3 lbs./1000 square feet or 140 lbs./acre. Reapply at 3-4 month intervals.

Spot Treatment or Supplemental Application: **PROMATE® SCATTER®** 3 lbs./1000

square feet every 7 days until problem is corrected.

NOTE: **PROMATE® SCATTER®** can enhance uniform turf seed grass germination by improving water availability and improving drainage. Scatter 1½ lbs./1000 square

feet during soil preparation for seeding. Then continue applications according to instructions noted in Fairways, Lawns, and Athletic Fields section of label.

ORNAMENTALS

Planting soils: Thoroughly mix or incorporate **PROMATE® SCATTER®** at 1 - 2 lbs. per cubic yard of soil.

GARDEN & LANDSCAPE

Trees and Shrubs: **PROMATE® SCATTER®** 6 lbs./1000 square feet uniformly form drip line to trunk. Repeat every 3 to 4 months.

Beds (Flowers, Shrubs): **PROMATE® SCATTER®** 3 lbs./1000 square feet every 3 to 4 months.

Installation

Trees and Shrubs: **PROMATE® SCATTER®** 0.75 lb. into hole and then apply 1 lb. over the surface for each foot of rootball diameter. Or, thoroughly mix 3½ lbs./cubic yard of backfill. Then continue applications according to instructions noted in Trees and Shrubs and Beds section of label.

Sodding and/or Seeding: **PROMATE® SCATTER®** 3 lbs./1000 square feet or 140 lbs./acre after laying sod or applying grass seed.
