DIRECTIONS FOR USE

Add IMPRESSIVE DB to the spray tank mix at the rate specified by the pesticide label. See the USE RATE section for information on rates. Before mixing the spray solution it is recommended that a compatibility test be performed in a small (1 qt.) container.

USE RATE

Use IMPRESSIVE DB at 2.25 lbs./acre. (1-BAG/45 pounds) of IMPRESSIVE DB treats 20 acres. Always check the pesticide label for specific use directions.

MIXING INSTRUCTIONS

IMPORTANT - Add IMPRESSIVE DB to the spray tank first before adding any other tank mix product, unless the tank mix pesticide(s) or additives direct otherwise.

Mixing Order

- 1. Fill tank 1/2 full of water and begin agitation.
2. Slowly add the required amount of IMPRESSIVE DB and allow the product to completely dissolve.
3. Continue filling spray tank with water and add the tank mix components as directed on the pesticide label(s).

STORAGE & DISPOSAL
