DIRECTIONS FOR USE

Ground application: For total spray volumes of less than 12 gallons per acre: Use 8-12 pounds of **TRACITE® STRIKE ZONE** ® per 100 gallons of total spray volume. For total spray volumes over 12 gallons: Use 12-14 pounds of **TRACITE® STRIKE ZONE** ® per 100 gallons of total spray volume.

Aerial Application: Use 14-18 pounds of TRACITE® STRIKE ZONE ® per 100 gallons of total spray volume
