DIRECTIONS FOR USE

GOLF COURSES (Greens, Tees, and Fairways) AND ATHLETIC FIELDS

For maintenance: Apply 4 ounces of PRO-MATE® SOAKER® per 1000 square feet in 2 gallons of water. Apply monthly, starting one month before the onset of stress conditions. Irrigate before next mowing, or leave baskets off to ensure that PRO-MATE® SOAKER® makes contact with soil. (It does not need to be watered in immediately after application.)

LAWNS - GENERAL TURF
