GENERAL INFORMATION

Myco-VAM® Bare Root Inoculum contains beneficial ecto- and endomycorrhizal fungi, ammonium carboxylates (Asset® RS) and water absorbing gel which expand root density, effectiveness, drought resistance and plant productivity. **Myco-VAM® Bare Root Inoculum** contains specifically selected mycorrhizal species for use in forestry, restoration, horticulture, and agriculture that reduce transplant shock and water use. **Myco-VAM® Bare Root Inoculum** is a dry powder that is mixed with water to form a slurry. Simply dip roots of bare root stock and plant normally.

SUGGESTED DIRECTIONS

Mix the contents of this package in four to five gallons of water or three packages in a fifteen gallon can. Let mix stand for 5 to 10 minutes, stirring occasionally. The product will form a slurry to adhere the active ingredients to the roots. Dip each plant or bundle for about 5 seconds. Continue to stir occasionally to maintain inoculum in suspension throughout the slurry.

One package of **Myco-VAM® Bare Root Inoculum** will treat 50 to 500 trees, depending upon root surface area of the transplants. **Myco-VAM® Bare Root Inoculum** is a compatible treatment for all woody plants except ericoids (Azalea, Rhododendron, Blueberries and Heather).
