GENERAL INFORMATION

SCATTER® is a blend of nonionic wetting agents impregnated onto an inert organic carrier. This results in a dry granular formulation that provides equal performances as liquid products when used at recommended rates. SCATTER® can be applied safely at full rates in both spring and summer. SCATTER® is particularly useful for treating small areas of difficult to wet soil. SCATTER® also contains agents to prevent foaming problems.

DIRECTIONS FOR USE

GREENS & TEES

In general, SCATTER® 21 lbs./1000 square feet every six months.

Early Season Applications: SCATTER® 6 lbs./1000 square feet. Apply when turf is dry. Rainfall or irrigation providing a minimum of 0.1 inch of water is necessary to activate the product. If necessary amounts of water have not been applied before next mowing, leave the baskets off.

Monthly Applications: If applied on a monthly maintenance basis, SCATTER® 3 lbs./1000 square feet.

Spot Treatments or Supplemental Applications: SCATTER® 3 lbs./1000 square feet every 7 days until problem is corrected.

Disclaimer: Always refer to the label <u>on the product</u> before using Helena or any other product.

NOTE: Rates given have been effective over a wide range of applications. Some applications may require lower, or higher rates for optimum performance. Experimentation will reveal the optimum rate for your specific application.

FAIRWAYS, LAWNS, ATHLETIC FIELDS

SCATTER® 9-12 lbs./1000 square feet every 6 months.

Growing Season: SCATTER® 3 lbs./1000 square feet or 140 lbs./acre. Reapply at 3-4 month intervals.

Spot Treatment or Supplemental Applications: SCATTER® 3 lbs./1000 square feet every 7 days until problem is corrected.

NOTE: SCATTER® can enhance uniform turf seed grass germination by improving water availability and improving drainage. Scatter 1 1/2 lbs./1000 square feet during soil preparation for seeding. Then continue application according to instructions noted in Fairways, Lawns, and Athletic Fields section of the label.

GARDEN & LANDSCAPE

Trees and Shrubs: SCATTER® 6 lbs./1000 square feet uniformly form drip line to trunk. Repeat every 3 to 4 months.

Beds (Flowers, Shrubs): SCATTER® 3 lbs./1000 square feet every 3 to 4 months.

Trees and Shrubs: SCATTER® 0.75 lb. into hole and then apply 1 lb. over the surface for each foot of rootball diameter. Or, thoroughly mix 3 1/2 lbs./cubic yard of backfill. Then continue applications according to instructions noted in Trees and Shrubs and Beds section of label.

Sodding and/or Seeding: SCATTER® 3 lbs./1000 square feet or 140 lbs./acre after laying sod or applying grass seed.

1 lb. SCATTER® = 17 oz. Volume

3 lbs. SCATTER® = 50 oz. Volume

5 lbs. SCATTER® = 84 oz. Volume
