#### FOLIAR APPLICATION RATES

Crop	QTS / Ac	QTS / Ac
Tree and vine-crops	2	1.3 - 1.6
Vegetables	1 - 1.5	0.9 - 1.1
Leafy Vegetables	1	0.7 - 0.9
Flower crops	1	0.7 - 0.9

Use a minimum of 25 gallons of water and a maximum of 100 gallons of water per acre. Apply Kendal every 7-12 days through the growing season.

#### FERTIGATION APPLICATION RATES

Crop	QTS / Ac
Tree and vine-crops	3.5 - 4.5
Vegetables	3.5 - 4.5
Leafy Vegetables	3.5 - 4.5
Flower crops	3.0 - 4.0
Turf crop	2.0 - 3.0 oz/1000 Sqf every 7-14 days

**Apply KENDAL every 15 days through the growing seasons.**
