GENERAL INFORMATION

0.8 lbs/gal of Nitrogen, out of 2.652 lbs/gal of the total Nitrogen in this product, is controlled release. This product is recommended for use as a supplement to a regular fertilizer program only. Foliar fertilization is intended as a supplement to a regular fertilizer program and will not by itself provide all the nutrients required by crops or other intended plants.

PRECAUTION: Use of this product in accordance with label directions is not expected to adversely affect normal vegetative and/or reproductive growth in most situations. However, various environmental and agronomic factors, such as crop stress associated

with high temperatures and/or dry conditions, make it impossible to eliminate all risks associated with the use of the product; therefore, crop injury is always possible. The user assumes all risks of use and handling. In an effort to reduce the risk of crop injury, apply early morning or late evening.

GENERAL RECOMMENDATIONS

VEGETABLE & FRUIT: 2 - 3 gallons/acre per growing season. Split into minimum of two applications, with 1/2 at early bloom and repeat at fruit set.

CUCUMBERS, SQUASH, MELONS, PUMPKINS: 1 - 3 gallons/acre at early bloom and repeat 4 - 6 weeks later.

GREEN BEANS, PEAS, LIMAS, SOYBEANS: 2 - 3 gallons/acre at early bloom and repeat at pod fill.

GRAINS, SEEDGRASS, RICE: 2 gallons/acre early season, 2 - 3 gallons/acre at flag leaf to flowering.

SWEET CORN: 1 - 2 gallons/acre early season and repeat at early tassel or silk. Can also use as "pop-up" starter in mixtures with other fertilizers.

POTATOES, CARROTS: 2 - 3 gallons/acre midseason at tuber initiation or elongation. Can also use as "pop-up" starter in mixtures with other fertilizers.

APPLES, PEARS: 1 - 2 gallons/acre when at bud stage, repeat 30 days later. Post harvest apply 3 - 5 gallons/acre.

OTHER CROPS: 2 - 3 gallons/acre when adequate foliage is present and repeat at flowering or fruit fill.

GREENHOUSE, ORNAMENTALS FERTIGATION: 3 - 5 gallons/acre every 30 days.

TOBACCO: 6 - 10 qts. per acre. Apply at plant bed stage to near maturity as needed to maintain crop growth and quality.

STORAGE

Do not store in unmarked containers. Store in area that is protected from excessive heat (32°C or 90°F) and moisture.

MIXING & APPLICATION

Add 1/2 total water to spray tank.

Turn on recirculation line.

Add any pesticides or other materials.

Add desired amount of CoRoN®.

Bring water to final volume.

Apply in adequate spray volume for complete coverage.

For fertigation treatments, add concentrate to injection tank.
