Apply at least 1 quart per acre in all foliar applications. Use higher rates as spray volume increases. NutrAsyst™ can be added to all foliar sprays. If sprayed without mixing with other nutrients, dilute in at least 10 gallons of water. If applied in spray mixes with copper based fungicides, keep pH at 6.0 or above.

TRANSPLANTING OR CUTTING: Mix ½ gallon NutrAsyst™ per 20 gallons of solution.

COOL SEASON GRASSES: Include with all foliar nutrient applications at one quart per 25 gallons of spray volume. Use alone before, during or after stress periods at 1.5- 3 fluid oz per 1000 sq. ft., or 2 quarts per 25 gallons of spray volume. APPLICATION WITH LIQUID FERTILIZERS: Use at the rate of 1 quart to 2 gallons per acre in liquid starter on pop up fertilizers. Do jar test for compatibility.

APPLICATION WITH DRY FERTILIZERS: May be impregnated into dry fertilizer at a rate of 1-8 quarts per ton of dry fertilizer. The addition of absorptive carriers to reduce fertilizer bridging/caking is recommended.

NutrAsyst™ is compatible with most fertilizers, pesticides, fungicides, and plant growth regulators. SPRAY MIX COMBINATIONS WITH SELECTIVE AND PRE-EMERGENT HERBICIDES ARE NOT RECOMMENDED.
