BIO- FORGE is recommended for any crop under any conditions of stress:

Any crop that is under stress from any source. Apply after stress symptoms appear. This includes drought stress.

Any transplant. Apply within 7 days after transplanting.

Any plant with herbicide toxicity. Apply when toxicity is first observed. Apply along with the first insecticide application. Many sucking insects can create toxins, which cause bud dor mancy.

Apply to all nursery crops or any crop that demands quick growth. **BIO-FORGE** will help crops "grow- off".

Apply **BIO- FORGE** on crops that are flood irrigated. Apply 6 days before irrigation. **BIO- FORGE** will reduce yellowing from irrigation stress

Apply **BIO- FORGE** to any plant that will be exposed to restricted water supply. **BIO- FORGE** will help plants maintain a more favorable water balance.

Harvest Plus is a fluid nutrient compound designed to prevent nutrient deficiencies in plants.

Harvest Plus is a valuable supplement to soil applied nutrients and is particularly beneficial under conditions where soil nutrients are not readily available

Harvest Plus has a pH of 1 to 1.5. The use of buffering agents may result in crop damage.

Harvest Plus will disperse in water with little agitation. Many pesticides can be added and applied while spraying Harvest Plus.

Water Harvest Plus Pesticide

Stoller's Harvest Plus will:

- ▶ is non- toxic when used according to directions

Directions for use:

Apply as a foliar spray in a volume of water sufficient for thorough coverage.

Vegetables: To supplement soil- supplied fertilizer, foliar spray 2 to 4 quarts per acre (4 to 9 liters per hectare) at weekly intervals. Start when crops are a few inches high. Continue up to 2 weeks before final harvest.

Tree fruit and nuts: Apply 2 to 4 quarts per acre (4 to 9 liters per hectare), 5-6 times annually beginning with delayed dormant spray.

Citrus: Apply 6 to 8 quarts per acre (14 to 18 liters per hectare), 4 times annually with first application at pre- bloom.

Field crops: Apply 2 quarts per acre (4 liters per hectare) when crops reach 4- leaf stage. Repeat every 14 days thereafter until crop matures. Use enough water for thorough coverage.

Turf grasses: Use 1 quart in 20 to 100 gallons for every 5,000 square feet. Start when grass turns green. Repeat every 3-4 weeks until grass goes into dormancy. The technology used to manufacture this product is unique. This product is designed to supplement a soil fertilizer program, not eplace it. Frequent use of this product will insure adequate nutrition for your crop.

Recommendations for use: Golden Harvest Plus may be used on the following crops: alfalfa, almonds, apples, artichokes, asparagus, avocados, barley, all beans, broccoli, cabbage, carrots, cauliflower, celery, citrus, corn, cotton, grapes, hops, lettuce, melons, milo, nectarines, peaches, peanuts, peas, pecans, peppers, pistachios, potatoes, prunes, rice, soybeans, sorghum, strawberries, sugar beets, sugarcane, sunflowers, sweet corn, tobacco, tomatoes, turf, turnips, walnuts, watermelons, wheat and most other crops.
