## General Information

**BIO- POWER** is intended as a supplement to a regular fertilization program and will not, by itself, provide all the nutrients normally required by agricultural crops. **BIO- POWER** can be used with a starter fertilizer, in-furrow, transplant water, drip or overhead irrigation/ soil drench or foliar treatment for any crop. **BIO- POWER** is water- soluble and will be taken up by plant roots, seed and foliage without phytotoxicity when used as directed. **BIO- POWER** is particularly effective as a fertilizer supplement for stressed crops.

## GENERAL USE DIRECTIONS

**STARTER FERTILIZER:** Apply 3 to 6 pints of **BIO- POWER** per acre mixed in with the starter fertilizer solution

**IN- FURROW:** Apply 3 to 4 pints of **BIO- POWER** in 5 gallons of solution per acre and apply in seed furrow at planting.

**FOLIAR:** Apply 1 to 3 pints per acre in sufficient spray solution to ensure thorough coverage of foliage.

**DIP SOLUTION:** Mix 8 to 10 fl. oz. in 10 gallons of water. Dip the roots in the solution before planting.

**TRANSPLANT SOLUTION:** Mix 3 to 4 pints/ acre in sufficient transplant water to transplant one acre of crop.

**IRRIGATION/ SOIL DRENCH:** Prepare a tank mix solution to inject 48 to 64 fl. oz. per acre into the irrigation system. Apply **BIO- POWER** near the end of the watering cycle .

**CROPS (but not limited to) :** Beans, Berries, Cereals/ Small Grains, Citrus, Corn, Cotton, Cucurbits, Forage Crops, Nursery Crops, Nut Crops, Ornamentals, Peanuts, Potatoes, Pulse Crops, Rice, Sod/ Turf, Soybeans, Sugarbeets, Tree Fruit, Vegetable Crops, Vine Crops

## Mixing Instructions

**Many pesticides may be mixed and applied with BIO POWER.**

Mixing sequence: 1. Water, 2. **BIO- POWER** 3. Pesticide

Always conduct a "jar test" utilizing all products to be mixed in proper proportion in order to establish compatibility.
