**METHYLATED SOYBEAN OIL<sup>PLUS</sup>** is a multicomponent herbicide spray adjuvant derived from methylated soybean oil and a nonionic surfactant blend. University tests have shown that methylated seed oils plus surfactant blends provide improved performance of certain postemergent herbicides. **METHYLATED SOYBEAN OIL<sup>PLUS</sup>** will provide improved leaf coverage and retention of herbicides on leaf surfaces for enhanced control of weeds under temperature or moisture stress. Apply **METHYLATED SOYBEAN OIL<sup>PLUS</sup>** at a rate of 1 1/2 to 2 pints per acre. The higher rate may be required when weeds are stressed due to heat or drought or populations are extremely high.

**METHYLATED SOYBEAN OIL<sup>PLUS</sup>** may be used as a substitute when herbicide labels recommend the addition of a crop oil concentrate or either a nonionic surfactant or crop oil concentrate to the spray mixture. Always refer to the herbicide label for additional recommendations and precautions.

**ALWAYS ADD SURFACTANT LAST TO THE SPRAY MIX AND CONTINUE AGITATION WHILE FILLING THE TANK.**

**STORAGE AND DISPOSAL**
