Golf course tees, greens and fairways; sod farms; commercial and residential lawns.

#### **SOIL APPLICATION RATES**

Apply 1-2 quarts per 1000 sq. ft. on soil before or after seeding and till or water into soil. Over newly harvested areas of perennial sod, spray and water into the soil or fertigate 1-2 quarts per 1000 sq. ft. May be applied to soil through irrigation systems at 1-2 quarts per 1000 sq. ft. (10-20 gallons per acre).
