

Brandt EDTA Iron

Chelated Trace Elements

General Recommendations

BRANDT EDTA IRON is recommended for the prevention and/or correction of Iron deficiencies in all crops. BRANDT EDTA IRON is fully chelated and designed for mixing with NPK starter fertilizers including those made with orthophosphate and/or containing pesticides.

Soil Application

Soil applications may be made by drip, sprinkler or furrow irrigation systems or in band or broadcast fertilizer applications.

Vegetable and Field Crops: 2-10 quarts per acre.

Tree And Vine Crops: 2-10 quarts per acre. 2-10 tbsp. per inch of tree diameter.

Foliar Application

Trees (Citrus): Apply 1 pint to 1 quart per 100 gallons of cover spray any time except during bloom or when fruit is on the tree. For severe deficiencies apply 2-4 pints per acre. Aerial applications and low volume application should not exceed 1 pint per gallon of water.

Trees & Vine Crops (excluding citrus):

Dormant/delayed dormant before bloom, then after full bloom as needed: 1 pint to 1 quart per acre in sufficient spray volume for thorough coverage (25 gallon minimum).

Smooth Skinned Fruit (peach, pear, apple, etc.): 1 pint per acre in 50-100 gallons of water.

Vegetable & Field Crops (ground equipment): Apply 1 pint to 1 quart per acre in sufficient spray volume for thorough coverage (15 gallon minimum for 1 pint; 25 gallon minimum for 1 quart).

Optimum rate of application will vary between fields, depending on soil pH and organic matter content. For best results, follow soil test or plant analysis recommendation.

Put 1/3 of water in tank. Add other chemicals, if any. Fill tank with balance of fertilizer or water. Add correct amount of EDTA IRON. Agitate adequately to mix.
