

# Brandt EDTA Magnesium

## Chelated Trace Elements

### General Recommendations

EDTA MAGNESIUM is intended for the prevention and/or correction of Magnesium deficiencies in all crops when determined by a soil test or plant tissue analysis. Because EDTA MAGNESIUM is fully chelated it is designed for mixing with liquid NPK starter fertilizers including those made with orthophosphate and/or containing pesticides.

### Row or Band Application


Apply 3-5 pounds (1-2 quarts) EDTA MAGNESIUM per acre, just before or at planting time.

### Broadcast Application

Apply 5-7 pounds (2-2.5 quarts) EDTA MAGNESIUM per acre, just before planting and work into the top 3-5 inches of soil.

**Note:** For foliar application, EDTA MAGNESIUM may be used at the rate of 2-4 pounds (1.5-3 pints) per acre with a minimum of 20 gallons of water. Or use BRANDT MANNI-PLEX MG for foliar applications.

*Optimum rate of application will vary between fields, depending on soil pH and organic matter content. For best results, follow soil test or plant analysis recommendation.*

### Mixing Instructions

Put 1/3 of water in tank. Add other chemicals, if any. Fill tank with balance of fertilizer or water. Add correct amount of EDTA MAGNESIUM. Agitate adequately to mix.

**Caution:** Check compatibility by utilizing a jar test before mixing.
