For best results, apply 4 times per year at the rate of 10 pounds per 1,000 square feet per application.

First application should be in early spring, second application in early summer, third application in late summer, and last application in the fall.

Apply the prescribed amount of fertilizer evenly and uniformly. Irrigate the treated area following application. **CAUTION:** Iron and other plant nutrients can cause staining. This product contains iron and should be swept off concrete immediately after application and prior to irrigation.
