DIRECTIONS FOR USE

NEWLY TRANSPLANTED: Side-dress 200 pounds per acre* or 15 1/4 pounds per 1,000 feet of row to get 42 pounds nitrogen (N), 8 pounds phosphate (P_2O_5), and 18 pounds potash (K_2O). Can be hand applied at 1/2 ounce per plant around drip line.

ONE-YEAR-OLD PLANTS: Side-dress 400 pounds per acre* or 30 pounds per 1,000 feet of row to get 84 pounds nitrogen (N), 16 pounds phosphate (P_2O_5), and 36 pounds potash (K_2O). Can be hand applied at 1 ounce per plant around the drip line.

TWO-YEAR-OLD PLANTS: Side-dress 555 pounds per acre* or 42 pounds per 1,000 feet of row to get 117 pounds nitrogen (N), 22 pounds phosphate (P_2O_5), and 50 pounds potash (K_2O). Can be hand applied at 1-1/2 ounces per plant around the drip line.

THREE-YEAR-OLD PLANTS: Side-dress 600 pounds per acre* or 46 pounds per 1,000 feet of row to get 126 pounds nitrogen (N), 24 pounds phosphate (P_2O_5), and 54 pounds potash (K_2O). Can be hand applied at 1-2/3 ounces per plant around the drip line.

DIRECTIONS FOR USE (cont.)

MAXIMUM APPLICATION RATE: 225 pounds per acre, 3 times per year.

*Application rates per acre are based on 40-inch row spacing.

The directions given should be used as a guide. A soil analysis is recommended before each application. Grower judgment and experience should be used with this and all other fertilizer products.
