GENERAL INFORMATION

MIX #28 is a fertilizer blend designed to produce vigorous, high quality field grown plants. The ingredients in this multi-nutrient formulation provide a fully charged soil base, bringing the soil nutrients to optimum ornamental levels. Applied prior to planting and thoroughly worked into the top soil profile, this fertilizer blend will provide the plant with nutrients at the optimum levels. Incorporated, the nutrients are placed exactly where the plant needs them, at the roots. The complement of micronutrients are designed to supply the plant's needs for a full six months, when they would be normally reapplied in a top-dress application.

Full N-P-K Charge: Provides a solid base of N-P-K for plants to get off to a good start. **Provides Superior Plant Quality:** Promotes superior root development and color retention. **Micronutrient Base:** Contains a full complement of minor elements necessary for excellent plant growth and color.

DIRECTIONS FOR USE

Nursery Preplant: Evenly broadcast 1,000 pounds per acre or 23 pounds per 1,000 square feet of bed area to get 100 pounds of nitrogen (N), 200 pounds of phosphate (P_2O_5) , and 200 pounds of potash (K_2O) per acre. Thoroughly incorporate the fertilizer into the top 4 to 6 inches prior to planting.

Vegetable and Flower Garden Preplant: Evenly broadcast 1,000 pounds per acre or 23 pounds per 1,000 square feet of bed area to get 100 pounds of nitrogen (N), 200 pounds of phosphate (P_2O_5) , and 200 pounds of potash (K_2O) per acre. Thoroughly incorporate the fertilizer into the top 4 to 6 inches prior to planting.

DIRECTIONS FOR USE (cont.)

Caneberries: Apply 500 pounds per acre to get 50 pounds of nitrogen (N), 100 pounds of phosphate (P_2Q_1) , and 100 pounds of potash (K_2Q) per acre. Make the application in early spring. Evenly broadcast the fertilizer in an 18-inch band on both sides of the row. Do not ring or pile the entire dose of fertilizer next to the crown.

Strawberries: Apply 500 pounds per acre to get 50 pounds of nitrogen (N), 100 pounds of phosphate (P_2O_5) , and 100 pounds of potash (K_2O) per acre. Make the application in late summer or early fall, following bed renovation. Evenly broadcast the fertilizer in an 18 to 24-inch band directly over the row.

The directions given should be used as a guide. A soil analysis is recommended before each fertilizer application. Grower judgment and experience should be used with this and all other fertilizer products.
