This source of slow release nitrogen features a complete release of nitrogen as much by temperature as moisture. The polymer coated urea will release by osmosis through an extremely tough, ultra thin polymer coating.

DIRECTIONS FOR USE

Apply the amount of fertilizer prescribed evenly and uniformly. Irrigate the treated area following application. Generally, the prescribed application will be at the medium rate. Special conditions or situations might dictate the high or low rate. Applicator judgment and experience should be used with this and all other fertilizer products.
