DIRECTIONS FOR USE

Use 150 - 200 pounds of ProNatural[®] Soil Stimulant per orchard acre banded (375 - 400 pounds per treated acre) post-harvest or early spring. Rate can be increased under conditions of poor water quality, high sodium soils or soils with very low organic matter. Do not exceed 400 pounds per orchard acre banded (1,000 pounds per treated acre). ProNatural Soil Stimulant can be top-dressed under sprinklers or lightly incorporated. Not recommended for use under drip irrigation if drip is the sole source of water.

FIRST AID

In all cases, call a poison control center or doctor for further treatment advice.

IF SWALLOWED, call a poison control center or doctor immediately. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor.
