COMPATIBILITY: Always jar test new combinations for compatibility prior to field mixing.

 $\begin{array}{c} DIRECTIONS\ FOR\ USE \\ \text{Dilute\ one\ part\ } \textbf{ProNatural\ } \textbf{MAGNESIUM\ } \textbf{with\ } \textbf{20}\ \ \text{or} \end{array}$ more parts water. Apply using a spray method and in an adequate amount of water that will provide complete coverage of the plants. Use of a nonionic wetting agent may improve spray coverage of certain hard to wet plants. Do Not Apply Undiluted.

ProNatural MAGNESIUM can be included in a regular spray program on crops. Consult with a Wilbur-Ellis representative on compatibility with other spray materials. The rate of application will depend on the crop, stage of growth, and severity of deficiency. The maximum recommended rates are for mature, full sized plants. Reduce the rates proportionately when spraying smaller plants.

ProNatural MAGNESIUM may be used on legumes grain crops, root crops, cucurbits, cole crops, leafy vegetables, woody and herbaceous ornamentals, deciduous fruits, vine crops, tropical and subtropical fruits, and many other crops.

DIRECTIONS FOR USE (continued)
Alfalfa: Apply 2 to 16 fl. oz. per acre during periods of first growth and after first cutting at 4th to 6th leaf stage. The applications may be repeated 2 or more times through the growing season.

**Beans:** Apply 2 to 16 fl. oz. per acre at first cultivation and 12 to 14 days before blossoming.

Fruit Trees: Apply 8 to 80 fl. oz. per acre before blossoming and shortly after petal fall.

Potatoes: Apply 2 to 10 fl. oz. per acre at row closure. Application should be applied during periods of rapid growth or nutritional stress. Applications may be repeated 2 or more times through growing season.

Rice: Apply 2 to 16 fl. oz. per acre just before booting.

Wheat: Apply 2 to 16 fl. oz. per acre when plants are 6" high and 12 to 14 days before booting.

### FIRST AID
