Apply only as directed. Apply during the growing season. Andersons Golf Products Turf Fertilizer 10-20-20 supplies a high level of potassium and phosphate for soils low in these nutrients. Adequate potassium and phosphate levels help promote root development and resistance to stress.

Application Rates:

LOW RATE: 3.75 lbs./1,000 sq. ft.
MEDIUM RATE: 5.00 lbs./1,000 sq. ft.

For all applications:

- Apply to dry foliage.
- Water in after application with a minimum of 0.2 inches to help move particles into the turf canopy.
- Do not collect clippings for at least one mowing following application to avoid particle pick-up.

Cool Season Grasses:

- Apply at the MEDIUM RATE.
- Apply at the LOW RATE when temperatures exceed 85°F.

Warm Season Grasses:

- Apply at the MEDIUM RATE every 4-6 weeks during the period of active growth.

Store in a clean, dry place.
Reseal opened bag by folding top down and securing.
Use only in clean, dry spreaders.
Do not leave unused product in spreaders.
