Apply only as directed during the growing season. Turf Fertilizer 19-26-5 is designed for use when establishing new turf. This product can also be used to correct phosphorus deficiencies in the soil.

APPLICATION RATES:

LOW: 2.4 lbs./1,000 sq. ft.

MEDIUM: 4.8 lbs./1,000 sq. ft.

For all applications, apply to dry foliage. Water in after application with a minimum of 0.2 inches to help move particles into the turf canopy. Do not collect clippings for at least one mowing following application to avoid particle pick-up.

Cool Season Grasses:

- Apply at the LOW RATE or MEDIUM RATE as determined by use or soil test.

Warm Season Grasses:

- Apply at the LOW RATE or MEDIUM RATE as determined by use or soil test.

Store in a clean, dry place. Reseal opened bag by folding top down and securing. Use only clean, dry spreaders. Do not leave unused product in spreaders.
