### Application Rates:

LIGHT: 2.25 lbs./1,000 sq. ft.  
NORMAL: 4.5 lbs./1,000 sq. ft.

### For all applications:

- Apply to dry foliage.
- Water in after application with a minimum of 0.2 inches to help move particles into the turf canopy.
- Do not collect clippings for at least one mowing following application to avoid particle pick-up.

### Cool Season Grasses:

- Apply at the NORMAL RATE in the spring and fall months.
- Apply at the LIGHT RATE in the summer months or when temperatures exceed 85°F.

### Warm Season Grasses:

- Apply at the NORMAL RATE during the growing season.

### Storage and Use:

Store in a clean, dry place.  
Reseal opened bag by folding top down and securing.  
Use only clean, dry spreaders.  
Do not leave unused product in spreaders.
