

DIRECTIONS FOR USE

Apply only as directed during the growing season. Fluid Fertilizer may be applied as a foliar spray application on all turfgrasses (cool season and warm season species). Also, this product may be applied on all turf including golf course greens, tees and fairways, athletic fields and lawn areas. It may be applied to both wet and dry foliage. Water turf before next mowing to remove fertilizer from foliage.

If tank mixing with pesticides, test compatibility before adding to the spray tank. Low N application rates (0.1 - 0.2 lbs. N per 1,000 sq. ft.) may be repeated at 7 - 10 day intervals. Moderate N applications (0.3 - 0.5 lbs. N per 1,000 sq. ft.) may be applied at 2 - 4 week intervals. Not recommended for use when planting new turf areas.

Dilution Information:

Determine desired N application rate and intended dilution. Fertilizer should be applied at a finished spray solution volume of 2 - 4 gallons per 1,000 sq. ft. Add 1/2 of the total water to the spray tank. Activate sprayer agitation, measure appropriate volume of fertilizer concentrate to the spray tank. Bring spray tank to total volume of final solution. If tank mixing with pesticides, test compatibility before adding to spray mix. Perform a small jar test at the appropriate dilutions and allow to stand. Allow to stand, then check consistency of mix.
